
協作法在香港

ANCHOR STATEMENTS

I want our family to remain intact.

The children need to see that their Dad and I are working together for them.

I want to be able to go to our children's weddings.

It is very important for us both to come out of this okay.

I don't want this to go to court – we need to be able to sort this out ourselves.

My job is to ensure that the children are damaged as little as possible by this process.

QUESTIONS TO IDENTIFY ANCHOR STATEMENTS

When you look back at this time ten years from now, what are the key memories you'd like to have?

What is the best possible outcome you could hope for, for the whole family?

What do you want to avoid?

What really matters to you?

At the end of this process, what's really important?

PARTICIPATION AGREEMENT

+ In essence:

 The Solicitors and all experts engaged will play no part in any subsequent legal proceedings!

第一次四方會議

- Open the meeting, introducing the principles and process of collaborative
- Review and sign four way participation agreement
- Anchor statements
- Establish agenda
- Throughout the process, keep in mind constructive and sensitive approach, the client's voice, pacing and timing

THINGS WE HAVE LEARNED:

- + No case too big £38 million
- + International capability
- + Popular for prenuptial/postnuptial & cohabitation agreements
- + Strength is in the team all work together to assist clients

第一次四方會議

- Discuss what is happening for the children
- Discuss how financial information will be shared
- What other information/input is needed?
- Plan and confirm agenda for second fourway
- · Assign tasks before next fourway
- Schedule future fourway meetings (best to do this well ahead now)
- Practicalities agree location, who prepares post fourway minutes
- Recap: review and highlight successes
